- As per the provision under Section 65 (4) of Maharashtra University of Health Sciences Act, 1998, I am directed to communicate the decision of the Academic Council taken in its meeting held on 28/07/2021. The Academic Council has unanimously resolved vide its resolution No. 59/2021 to grant Continuation / Extension of affiliation to the B.P.Th. course of your college for the academic year 2021-2022 subject to following conditions:
 - (a) The intake capacity shall be B.P.Th. - 40
 - (b) It is mandatory to obtain the State Government permission (as applicable).
 - Fulfillment of following deficiencies and submission of its compliance report within Three (c) Months from the date of issuance of this letter without fail:

- Colleges are required to carryout Permanent approval process of the Teachers who have been granted temporary approval.



- To update Academic Online Teacher's Database of all teachers. On monthly basis review of availability of teachers shall be taken at College level & it shall be kept updated.

- You are requested to comply with the above mentioned deficiencies within a stipulated time without fail and submit compliance report.

- Although the Continuation / Extension of Affiliation is granted to your College for the Academic Year 2021-2022, you are not allowed to admit students for First Year BPTH Course without receipt of permission from State Government (As Applicable).
- The Dean / Principal of the College is hereby instructed to submit letter of permission from State Government (As Applicable).
- In case of any irregular admissions, University shall not be responsible for any academic or pecuinary loss or damages of the concerned.
